Attached for your information and retention are five (5) copies of the report to the Secretary of State by the United States Delegation to the International Conference on the Peaceful Uses of Atomic Energy held at Geneva in August, 1955. 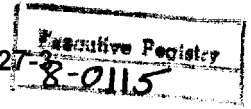
