Reference is made to your letter dated June 3, 1953, directed to Assistant Attorney General Warren Olney III, concerning the captioned matter.

On the day of sentence of [redacted] the United States Attorney agreed with the attorneys for the defendants that, after the information supplied by the defendants was checked, an evaluation of its completeness, accuracy and truthfulness would be furnished to the United States Board of Parole, without recommendation.

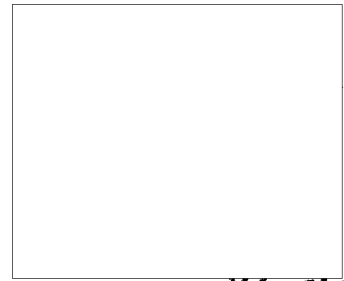

- ABERANDA - Towed by ALLEGEANCE from Hong Kong to Canton on 14 January 1951.
- BELUSAN - Towed by the MARGARET MOLLER to Canton on 12 January 1951.
- KENWOOD - Towed by the CAROLINE MOLLER to Canton on 23 January 1951.
- ETAMIN - No information reported by source.
- BENJAMIN PEIXOTTO - No information reported by source.

- EDGAR ALLEN**  
**POE** - No information reported by source.
- ANTELOPE** - Towed by the **CAROLINE MOLLER** to Shanghai on 23 August 1950.
- FLAGLER** - Towed by the **CAROLINE MOLLER** to Shanghai on 23 August 1950.
- HENRY L ABBOTT-** Intercepted in the Straits of Formosa by Chinese Nationalists while enroute to Shanghai on 18 September 1950. Later released to Lloyds and was returned to Hong Kong on 29 August 1951 where it was reportedly sold for scrap, presumably for the account of the new owners, the Great China Shipping Company of Hong Kong.
- JUAN DE FUCA** - Intercepted in the manner outlined above, but sank in heavy seas while in tow.

Substantiating data concerning precise dates on which scrapping may have been completed, or other alternative disposition made of these vessels, is not readily available. Because of the overt nature of these and related questions, it is probable that information could be more expeditiously obtained by direct investigation through the office of the U. S. Consulate General at Hong Kong. In a possibly related connection, the U. S. Treasury Department representative at Hong Kong may have information of value, due to his interest in the activities of [redacted] Security Officer for the T. Y. Fong interest in the Philippines. [redacted] was formerly employed by the Hong Kong Police Special Branch, with which
