Dear Senator Saltcristall:

Thank you for your letter of 6 June enclosing Form 57
for [redacted]

[redacted] had applied for a position with us in 1954 but we were not able to find a suitable place for him because he was not at the time a citizen of the United States. We note that he has since acquired U. S. citizenship and, assuming that he has held it for five years, the scope of our consideration can be broadened. In the meantime, however, the level of our recruitment has decreased substantially and most of our appointments are to Junior Officer Trainee positions which would not be appropriate for a man of [redacted] stature and responsible experience. There are of course occasional openings of a more specialized nature and we shall be glad to review his file for such vacancies. We have written to [redacted] to advise him that his file is being reviewed and enclose a copy of our letter to him for your information.

Your referral of [redacted] is appreciated and we shall advise you of the outcome of our current review of his application.
