Dear Senator Goldwater:

I have given careful consideration to your letter of 7 March 1961 written on behalf of a man whose son was listed as missing and presumed dead in the Korean War. You ask whether we have any information to indicate that the Chinese Communists had not released all American military prisoners.

This matter is primarily within the jurisdiction of the Departments of State and Defense. Any information we have received over the years on this subject has been passed to these Departments. Unfortunately we have no information to add to that which I understand the Department of State passed on to you recently.

As I had a son gravely wounded in Korea and still an invalid, I can particularly understand the grief of the man who has written you, and if we should obtain any further information I shall pass it on to you.
