Dear Mr. Mueller:

I have your letter of 21 April 1958 requesting that a representative of this Agency attend your forthcoming budget hearings before the Commerce Subcommittee of the House Appropriations Committee. As already explained to Mr. John T. Green, Director, Office of Technical Services of your Department, the Agency would be pleased to comply with this request if it is the desire of the Subcommittee concerned that Agency officials be present.

Our representative would attend to respond to questions pertaining to our activities in the field of translation of foreign language documents and distribution of the product. The Agency is not in a position to give specific support to the request for appropriations which presumably is the subject of the hearing. However, the Agency does support the objectives of your proposed program and believes that the United States as a whole and the Government will be benefited by greater availability and distribution of translated materials from other countries.

Within the above framework it is proposed that  and  will be available for attendance when your hearings are rescheduled. In the meantime, Mr. John E. Warner, our Legislative Counsel, will continue to be in touch with your Mr. Green to work out the details.



Dear General Cabell:

You will recollect your recent letter to me in which you outlined the views of the Central Intelligence Agency concerning our proposed Foreign Technical Information Center. Since then we have presented a budget request to the House and Senate Appropriations Committees and have had some preliminary discussion with the House Subcommittee on Commerce appropriations in connection with the general budget request of the Department. I regret to say that the plan appears to be in jeopardy. A substantial part of our difficulty lies in a feeling by members of Congress that we are attempting to "move in" or duplicate work which your agency is performing or is prepared to perform.

I am confident that the two lines of effort are distinct and that we can rely on the full cooperation of C.I.A. in distribution. However, our position would be greatly strengthened if a responsible official of C.I.A. could attend our hearings and be prepared to describe your mission and the limitations which do not permit you to undertake national distribution. Naturally we do not feel that we should call on you to support the precise details of our plan. However, a general concurrence and an assurance that it does not duplicate work which C.I.A. is prepared to encompass would be most useful. May we look forward to your assistance? Our hearing will be on Friday at 10:00 a.m. in the offices of the House Appropriations Committee.


