There has recently been set up in the Department of Commerce an Office of Strategic Information of which Mr. R. Karl Honaman is the Director. This office is looking into the entire problem of the publication of unclassified information that might be of value to a potential enemy with a view to recommending policies with respect thereto for the guidance of executive agencies of the government.

I have already discussed your letter with Mr. Honaman and have referred it to him for action. He has assured me that a member of his staff will get in touch with your office in the near future.

Again let me thank you for your interest in this matter. Your offer to cooperate is most gratifying.
