Reference is made to a claim filed with the Department
of Justice on 2 September 1959 concerning the indebtedness of

Considerations affecting the national security make it necessary
to request at this time exercise of the discretion vested in the
Attorney General to discontinue further action in the matter.
Our review of the information necessary for further prosecution
of the claim reveals that the information affects the
national security and may not be declassified.

behalf of the Central Intelligence Agency, in attempting to
arrive at a workable solution in this matter, are appreciated.
