Secretary Gates was out of town and the Director never did talk to him on the attached matter. He handed it back to me and asked me to see what General Cabell thought about it. I talked to the General and his view was that we should just file and forget unless the question is raised again. General Cabell said we were clearly on record with General Erskine as not desiring to participate in this particular briefing so, unless the Director does wish to go further and talk to Secretary Gates as a matter of courtesy, no further action is required.


SUBJECT: Briefings for the Secretary of Defense - Designate
