1. Through a representative assigned to a subcommittee dealing with the Cuban refugee problem which worked under the general direction of the Task Force chaired by Assistant Secretary of Defense for International Security Affairs, Paul Nitze, this Agency recently participated in the preparation of a proposed U. S. policy toward Cuban exiles. Inasmuch as the work of this committee treated the subject in considerable depth, it is felt that it perhaps was fully responsive to NSC Action Memorandum No. 42.

2. We are keeping in close and continuous touch with the Department of Health, Education and Welfare which has basic responsibility for this program. It, however, additional reporting or recommendations on this subject are desired, we shall be happy to comply.

SUBJECT: Assistance to Cuban Refugees

In approving the Record of Actions of the April 22, 1961, meeting of the National Security Council, the President directed that levels of support for Cuban refugees should be reported to him for recommendations for their improvement (NSC Action 2406 e). The President also expressed his desire that such support should be open and overt. In addition, he directed that the adjustment of Cubans to life in the United States should be given particular attention by the Department of Health, Education and Welfare.

Accordingly, it is requested that the secretary of Health, Education and Welfare and the Director of the Central Intelligence Agency submit a report to this office on these matters as soon as possible, together with such recommendations for the attention of the President as they deem appropriate.
