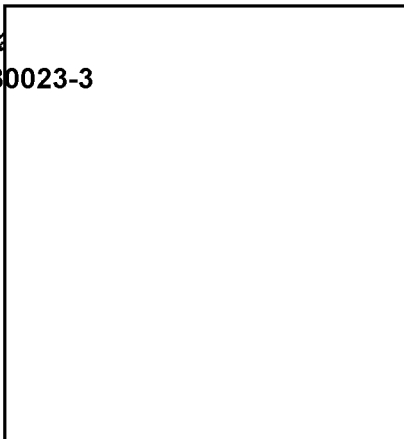

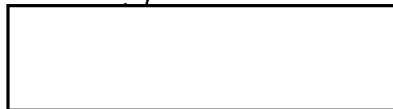

SUBJECT: Evasion and Escape Safe Area List

REFERENCE: Memorandum for the Director of Central Intelligence, from Chairman, Joint Chiefs of Staff, subject as above, dated 13 July 1961 (JCSM-472-61)

1. This memorandum requests the signature of the DCI on the attached memorandum to the Joint Chiefs of Staff.

2. The purpose of the attached memorandum is to inform the JCS of the programed production of the Safe Area Briefs and to request the JCS to establish the priorities for the production of the Safe Area Briefs to include evaluation of new Safe Areas. It will take three years to complete the Safe Area Brief Program for the Areas already approved by the JCS.
