Are Russians Lying About Shooting Down Our Plane?

Charges and counter-charges are being made in the United Nations Security Council regarding the United States Air Force RB-47 plane which is missing over the Barents Sea, but it is possible that in the exchange of bitter words the whole story hasn't been and will not be told.

The Russian delegate demands that the United Nations condemn the United States as an aggressor, risking World War III by continuing espionage flights over Soviet territory and territorial waters.

American chief delegate Henry Cabot Lodge denounced the Soviet charge that the plane was on an espionage mission as a "sinister fabrication." He described the shooting down of the plane of which the Soviets boast as "criminal and piratical."

But what if the Russians are lying when they say they shot the plane down, and the United States has fallen into the trap of believing the lie?

The International Services of Information, American private intelligence organization with contacts behind

the iron curtain) has just issued a bulletin declaring that the Russians did not shoot down the plane; that they knew nothing of the plane until this country reported it missing, that after they joined the hunt for it they found two rubber dinghies in the Arctic, far outside Soviet territorial waters, and then trumped up a claim that they shot the plane down in their territorial waters.

The ISI bulletin "Inform" adds that its sources in Murmansk do not know what brought the RB-47 down, but presume it was an accident.

If this information is correct, the "sinister fabrication" which Lodge charged was not only the lie that the plane was over Soviet waters, but also that they shot it down.

And if this information is correct, the Russians kidnaped the two airmen they claim to be holding and whom they say will be tried as spies.

By contrast, last winter the United States Navy rescued four Russian airmen and repatriated them.
