MEMORANDUM for Director, Central Intelligence Agency

SUBJECT: Ad Hoc Committee to review "Preliminary U. S. Policy
on Outer Space" NSC 5814/1


1. At the NASC meeting on June 30, 1959, the President approved the appointment of the subject committee to be chaired by Dr. Hugh L. Dryden, Deputy Administrator, NASA, and with representatives as follows:

2. You are hereby invited to nominate the representative of your agency.

3. The Chairman has asked that the first meeting of the Committee be held at NASA Headquarters, 1520 H Street, N. W., on July 16, at 2:00 p.m. The members are requested to come prepared to present their agency's views on the revisions to the policy that should be considered. These views may be presented orally, rather than in the specific and more detailed terms that it is assumed will be a part of the Committee's review. This first meeting will determine how detailed the subsequent review is likely to be and whether or not it will be necessary to appoint a working group to synthesize the various points of view into an initial draft of the policy paper.
