MEMORANDUM FOR: Director, Net Evaluation Subcommittee

SUBJECT: Intelligence Requirements of the NESC for  
1958-1959

1. Attached are Coordinated Intelligence Assumptions for NESC Exercise, 1958-1959, submitted in response to your request of 12 June 1958. These Assumptions were prepared by appropriate agencies, subcommittees and ad hoc working groups, and were approved by the USIB on 7 October 1958. Concurring were The Director of Intelligence and Research, Department of State; the Assistant Chief of Staff for Intelligence, Department of the Army; the Director of Naval Intelligence; the Assistant Chief of Staff, Intelligence, USAF; the Director for Intelligence, The Joint Staff; the Atomic Energy Commission Representative to the USIB; the Assistant to the Secretary of Defense, Special Operations; and the Director of the National Security Agency. The Assistant Director, Federal Bureau of Investigation, abstained, the subject being outside of his jurisdiction.

2. The USIB recognizes that for its purposes the NESC requires quite specific, unequivocal assumptions, and every effort has been made to provide them. Your attention is invited to the qualifications and caveats set forth in the Foreword of the Attachment. In view of these qualifications and caveats, as well as the special-purpose requirement to be met by the attached Coordinated Intelligence Assumptions, it is requested that these materials be given limited distribution.

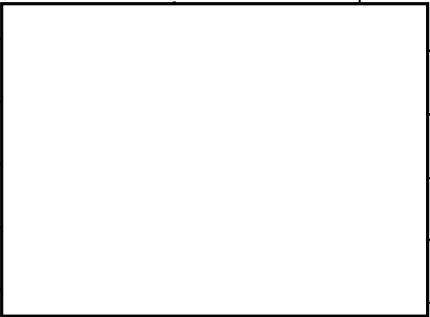
