SUBJECT: Training of Non-U. S. Nationals

1. This Agency has a continuing requirement to train a number of foreign nationals so that they may regain their proficiency, with principal emphasis at this time on single-engine aircraft including jet fighters.

2. It is not possible as yet to determine the total number of persons who will ultimately require this training, but it is anticipated that no one group in training will exceed 8 to 12. Each individual at one time was a fully qualified pilot, but the current status of each may be expected to vary widely - i.e., from no flying for ten years to currency in light planes.

3. The assistance of the United States Air Force is requested in satisfying this requirement on a reimbursable basis. If this is favorably considered, it is suggested that you designate a member of your staff with whom details of this requirement may be more fully discussed.
