MEMORANDUM FOR: Secretary of the Air Force

SUBJECT : Implementation of DOD Directive No. S-3115.2,
dated 13 July 1955

REFERENCE : Secretary of the Air Force Memorandum of 31 October 1955,
same subject

1. This acknowledges receipt of your memorandum of 31 October 1955 proposing the issuance of implementing instructions to accomplish certain actions required by reference Directive.

2. The Agency has serious reservations concerning these proposed actions. The establishment of the Technical Processing Center at Dayton will result in dissipation of the important human assets of the Army-Navy Electronics Evaluation Group (ANEED) which have been laboriously built up over the last three years by the Army, Navy and CIA. The location of ANEED at the Navy Security Station in Washington has permitted effective exploitation of ELINT with collateral and with related COMINT by the three agencies concerned.

3. In the opinion of this Agency, the proposed location of the Technical Processing Center at the Air Technical Intelligence Center will not provide for "optimum interaction and mutual support between ELINT and COMINT in order to produce efficiently the best possible ELINT results for all users..." as required by DOD Directive No. S-3115.2.

4. It is also the opinion of the Agency that the proposed location of the Technical Processing Center will not result in "effect(ing) fullest and most expeditious processing possible" because of the difficulties of providing collateral support by CIA, inaccessibility to the intelligence community generally, and the inefficient movement of personnel between the intelligence organizations in Washington and Dayton. A parallel question was adjudicated by the community in relation to a proposed move of NSA to Fort Knox abandoned in favor of the location at Fort Meade.

5. The proposed location will not satisfactorily serve all Agency requirements with respect to certain high priority scheduled operations. As a consequence, the contribution which the Agency can make to the community activity will be diluted by the necessity of meeting Agency needs by other means.

6. The Agency recognizes the Air Force responsibility for establishing the Technical Processing Center and that this is a matter of primary concern to the Department of Defense. For this reason, the Agency will interpose no objection to establishment of the Center as proposed. However, the Agency has major reservations on whether the arrangements will meet its needs and therefore, I recommend that you reconsider this decision.
