- 1. Action is recommended in para 5, below.
- 2. Ref a., comprises an intelligence summary on certain aspects of the Middle East situation, specific policy suggestions for dealing with some aspects of the situation and a recommendation that there be improved coordination among United States government agencies concerned with Middle East problems through some such instrumentality as a "cold war watch committee."
- 3. Ref b., states agreement with the intelligence summary and concurrence with the appreciation of the situation conveyed in ref a., and requests "... personal comments and guidance ... in connection with preparation of a reply ... to ref a., for the signature of the Chief of Staff. USAF.
- 4. The Near East and Africa Division feels that it would be appropriate for the Agency to comment on General Lindsay's appreciation of the situation and his intelligence summary, but possibly inappropriate for us to comment either on his specific

policy recommendations or on his recommendation for the formation of a new element in the government to devise and implement a "master plan" to deal with the Middle East.
