Dear Admiral Davis:

As you know, a primary concern of the Intelligence Community is the collection of vital information by means of airborne electronic systems overflying denied territories.

In a continuing effort to increase our capability in this field, we asked the Air Force almost two years ago to recommend a more advanced vehicle to replace the aircraft now used. As a result of that recommendation, this Agency made arrangements for the Air Force to procure for us a total of seven P2V-7 (RB-69A) aircraft which, when modified and equipped with the most advanced equipment available, were to be assigned to overseas areas.

Recent favorable developments in other areas of our collection efforts, however, have lessened the requirement for which the P2V-7's were being obtained. As a result, we have decided to reduce the number of these aircraft from seven to five. This decision has been reached only after a careful evaluation of the overall requirement of the Intelligence Community and is based on considered reasoning.

I am aware that this reduction will present problems to you and the various elements of your staff which have been supporting this program since its initiation over a year ago and I want to assure you and your associates that we are most appreciative of the time and effort which has been spent on it. I am confident that support of the same high caliber will continue in your headquarters and will be provided by your overseas commands.

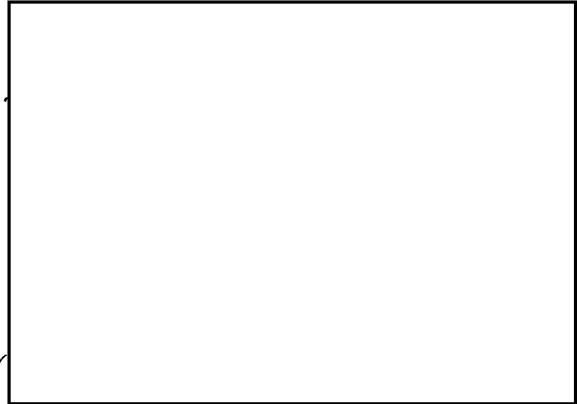
