1. It is desired that immediate action be taken to give special handling to the [redacted]

2. This is to be considered a highly sensitive research and development project and, pending further instruction from the Director of Central Intelligence, is to be retained entirely within U. S. channels for analysis and reporting.

3. If this requires a special code word, please take appropriate action accordingly. In the event the administrative mechanics of establishing this system cannot be accomplished immediately, the read-out and analysis of the product should be kept extremely limited on a "need-to-know" basis until the mechanics are established.
