PRESENT: General Smith, Messrs. Wisner, Wolf, Becker, Hedden, [redacted]

The Director stated that he still had Mr. Hedden's study on OSI and asked if there was anything further he had to do on this. Mr. Hedden said no further action on this matter was required by the Director. The DCI then noted that the "Pentagon" appeared to be satisfied with the results of the recent meeting held by the Scientific Intelligence Committee.

Mr. Wolf and Mr. Wisner reported on the recent cable from [redacted] concerning operations against the [redacted] and [redacted] request for additional personnel. In this connection, Mr. Wisner noted that in this case [redacted] was somewhat at fault since we had asked him on several occasions to advise us of his personnel needs in order that this matter could be cleared with State. The Director stated that [redacted] and the other Senior Representatives and Staff Chiefs should be kept informed of the status of their requests for additional personnel. Mr. Wisner noted that such a practice was in effect.

Stated that an urgent request had been received from Colonels [redacted] concerning a supply mission by air [redacted] After some discussion, wherein Mr. Wisner pointed out that (1) this mission might prove expensive if the aircraft was lost (\$600,000); (2) we could not requisition air transportation from the Air Force; (3) we would, therefore, be required to contract air transportation, the Director stated that (1) we still had a large reserve for operations; (2) he believed that we were fully covered by the NSC on such operations; however, we should double-check before going ahead; (3) [redacted] should be notified of the action taken. 25X1
