Deputles' Meeting

Tuesday, 9 December 1952
PRESENT: General Smith, Messrs. Dulles, Wisner, Wolf, Amory, 25X1
a. Stated that in going over cables he was continually reminded of the ludicrous pseudos assigned and directed that action be taken to "clean these up" both inside and outside the Agency in order that they would not be contemptuous if discovered. Mr. Wisner noted he had already spoken to his staff concerning this. The DCI remarked that we should go further and put this matter in the form of a directive. DD/P undertook to follow through on this.
b. Referred to a cable from views on the stations he has so far visited and noted, in particular, that had indicated that finance and audit support in the field would be useful.
