General Smith:

a. Noted the proposed JCS paper "Command Relationships Between the JCS/OPC Organization and the Armed Forces in Active Theaters of War Where American Forces are Engaged" and, after being advised by DD/P that comments on this paper would be furnished on 7 January, stated that (1) he desired that it be made clear that theater commanders would be responsible for support but not control of our activities; (2) the notation throughout the paper "CIA/OPC" would be changed to CIA.
