Thank you for your letter of 2<sup>nd</sup> June concerning an inquiry you received from Mrs. [redacted] about our action on her husband's application for re-employment with this Agency.

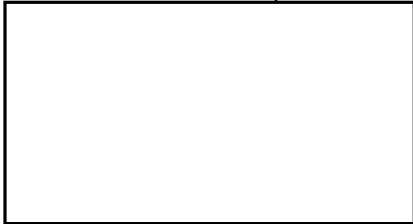

As you know, Mr. Burt has referred your application to us for consideration. As he mentioned to you, you have general qualifications of interest to us in connection with positions in our

We have also just received from Mr. Burt letters from Senator Henry M. Jackson and Congressman Clarence Cannon regarding your application. Both referred to your need for a positive determination on your application at an early date. Your file is under review by responsible supervisory officials to determine whether there is an opening commensurate with your qualifications. Further processing of your application (background investigation and evaluation) will depend on the outcome of this review. This processing involves a substantial period of time. As we understand it, you must know by September or earlier whether you will be offered appointment here. It is most unlikely that this could be accomplished. You say, therefore, wish to investigate other employment opportunities rather than deferring until final action can be taken here.

We do not want to discourage an applicant who is interested in employment with us but it would appear that it might be impractical to continue with your application in light of the time factors involved. If you do wish to remain under consideration, we shall be glad to proceed but we will defer action until you have an opportunity to consider the time factors and the possibility of a negative outcome and advise us as to your desires.

Your interest in our service is appreciated and we look forward to hearing further from you.
