Dear Senator:

This letter will acknowledge yours of June 4th with the very interesting attached memorandum summarizing your discussions with Mr. Georgi M. Korienko of the Soviet Embassy.

I regret the delay in my response; however, your letter was received in our mailing room on Friday, June 7th, and did not reach my desk until Monday morning. This was because the Staff wished to analyze the memorandum of your discussion with Mr. Korienko and submit their comments to me.

I feel you made a very good point in your discussion on the test ban agreement when you indicated to Mr. Korienko that it is the United States Government which has "bent all the way" in this negotiation. You will recall, as I do through my experience as Chairman of the Atomic Energy Commission from 1958 to 1961, that the Soviets originally agreed to on-site inspection and also to the establishment in the Soviet Union of 21 internationally-manned control posts. Although the number of inspections was never agreed to, nor was it specifically discussed, the principle of on-site inspection was recognized by the Soviets through the early years of negotiation. It seems to me that they have made no great concession in agreeing to 2 or 3 on-site inspections each year in view of the prior understandings on this subject.

I was very much interested in Mr. Korienko's statements concerning the Senate Resolution. This Resolution seemed very reasonable and his statement that it would work to the Soviets' disadvantage militarily indicates that their concept of war must

be a mass annihilation of people and cities through the use of very large nuclear weapons rather than an attempt to confine their attack to military installations, SAC bases, missile bases, etc. This is consistent with other Soviet statements which reflect their current policy toward the conduct of a nuclear war.

Mr. Korienko's views on the multilateral force are repetitious of statements made by others and I compliment you on your rejoinder that neither he nor any other Soviet spokesman will admit that they have built a massive medium range missile capability which has the power to utterly destroy Western Europe and Great Britain. This is legitimate from their standpoint, but any move made by the West to counter this massive threat brings on most violent statements and complaints from their side. I think this points up the illegitimacy of the arguments which Mr. Korienko advanced to you.

With respect to the attempt on the part of your office to hand-deliver the letter to me at our downtown office, which, according to the morning paper, created some problems, I am having a thorough investigation made by our Director of Security and will report to you when these findings are completed. In the meantime I very much appreciate your letter and the attachment.
