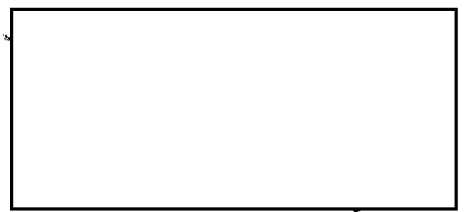



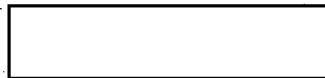


Thank you for your letter of 22 June to Mr. Dulles expressing your interest in employment with the United States Government.
