Dear Mr. Dulles:


At this time, when you are so sorely assailed by Fortune's slings and arrows, I would like you to know that I for one have never lost faith -- I know of no men in whose hands I would rather place responsibility for this country's safety than you and J.C.

The main purpose of this letter, however -- for I would not intrude on your time merely to tell you that I am one of your many loyal supporters -- is to say that I have accepted an appointment at Harvard in their international legal studies program, and shall commence work up there the tenth of this month. My address will be: Kendall House, Harvard Law School, Cambridge.

In my opinion, there is still a way to salvage the Cuban situation to our advantage, and to restore our prestige there and in Latin America, but I know better than to proffer unsolicited advice to the State Department, at least until I have served long enough at Harvard for my counsel to be considered more disinterested than it could be while I was with ITT.

1 Attached is a letter to Mr. George Eder, prepared for the signature of the Director.

2. Also attached are Mr. Eder's letter of 4 May to the Director, Mr. Eder's letter of 10 May to a member of WH Division, and a study by Mr. Eder entitled, "Reappraisal of United States' Policies in Latin America." Mr. Eder has asked for the return of this copy when convenient.

3. Mr. Eder is a very prolific writer, and his interests are many and varied. While his approach is almost always that of an upper-class Latin American, he is by long and broad experience acquainted with most of the basic problems of Latin America and United States' relations with Latin America.
