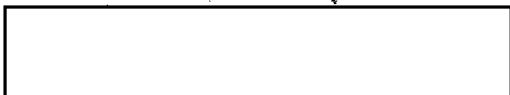

Dear Mr. Dulles:

As an assignment for an English class at Eastern Kentucky State College I am writing a research paper. The subject I have chosen is "Religion vs. Nazism". I am investigating to what extent the German Church opposed Nazism. After reading your book Germany's Underground, which I thoroughly enjoyed, I feel that you could answer several questions which have come to my mind.

It is my understanding that the church did not oppose Nazism to the fullest extent. While reading various articles, however, I have found much emphasis upon church opposition. Did the church greatly oppose Nazism, or did they try to ignore the situation? Did the youth of the church show much opposition? Dear Miss Houston:

The assignment you have chosen regarding the religious opposition to Nazism is, indeed, a challenging one. My own views on this matter are by no means comprehensive, nor would I presume to advance an analysis when there is such an extensive amount of published material on this subject by people who were more directly engaged in the problem.

It is my opinion that you will find it difficult, even after a thorough study of the facts available, to arrive at a clear decision about the degree of church opposition to Nazism and the effect this opposition had on the growth of Nazi power. Church members and officials reacted to Nazism in accordance with individual political assessments, which understandably varied greatly, and their individual consciences. Although the economic, political, and psychological situation in Germany provided unusually favorable conditions for the rise of Nazism, the churches generally impeded the rise of Nazi influence and opposed even more sharply the consolidation of Nazi power.

In assessing church potential for resisting German civil authority, furthermore, it is important to avoid too close comparison with our own system, which does not impose state authority on the churches. Since the Religious Peace of Augsburg, in 1555, the principle expressed in the Latine Cris regio, eius religio has profoundly influenced the position of the churches in Germany.
