I should like to use this occasion to wish you success in your undertaking.

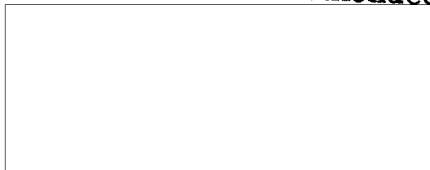

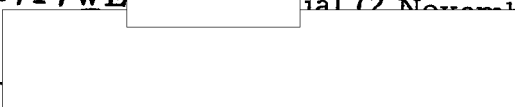

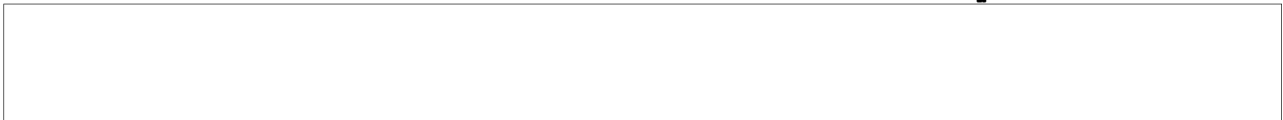
