Messrs. C. Allen Dulles & J. Edgar Hoover:

Gentlemen:

I am addressing a copy of this to each of you, in the hope that it will reach one of you - and, that, if it does, it won't be cast aside as the figment of imagination of a crank.

Incidents of the past few months have caused me to revive a project that I worked on for a long time. The incidents were those of the two recent "defectors", the "top secret" document that was supposedly lost in the Elctra crash in Boston and the present concern (according to the newspapers) of the possibility of additional defecting cryptographers.

For a long time I have been interested in formulae, equations and the like and, believe it or not, I have developed and perfected a method of encoding messages, specifications, etc., that is impossible to break, without the "key". It may seem fantastic to claim the following but such are true.

1. To repeat, it is impossible to break without the key.
2. If, by chance, the key falls into wrong hands, a simple change in formulae makes it impossible to break future messages or previous ones, if they had key changes.
3. The formulae may be changed daily, hourly, even for each message, if desired, without adding to sending or receiving labor.
4. The moment the method is revealed to you, the key may be changed so that even I cannot decode.

Let me state my proposition:

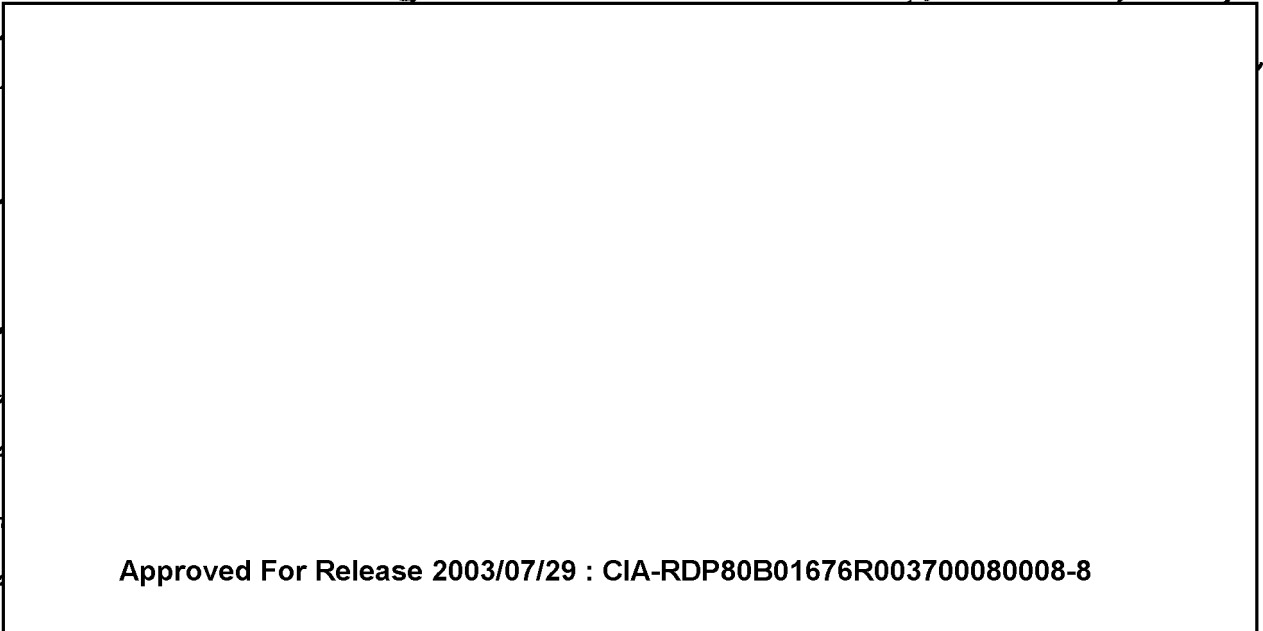
A. If any of my above claims are proven wrong, I'll give you the formulae, if you are interested.

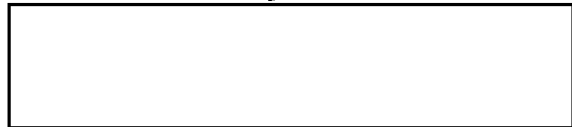

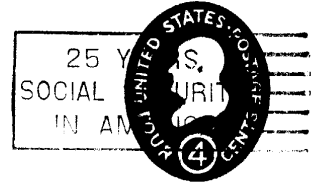
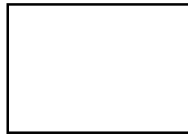
