The Stockberger Award, first presented in 1948, was established by the Society for Personnel Administration to honor the memory of its first president, **Dr. Warner W. Stockberger**. Dr. Stockberger, a

pioneer and leader in federal personnel administration, was the first director of personnel for the U.S. Department of Agriculture.

7. Participation in IPMA International Conference activities as chairperson, speaker, or panelist.

Canadian

• The 1977 Canadian Region Conference, which is being held May 22-27, Edmonton Plaza Hotel, Edmonton, Alberta, features a program built around the theme, "The Responsible Public Servant."

Tom Gould, director of news services, CTV Network, Toronto, will deliver the keynote address. Other sessions will examine responsibility in labor relations, responsibility in bilingualism and biculturalism, the psychology of responsibility, and military-style responsibility.

There are also 20 breakfast discussion topics and concurrent sessions on EEO, the Anti Inflation Board, ombudsmanship, participation and involvement, and job analysis.

Neil A. Murray, senior classification and compensation officer, Employee Relations Division, Alberta Personnel Administration, is chairman of this year's conference.

• A two and one-half day workshop on the "Basics of Personnel Administration" was conducted by the region, May 4-6, 1977, in Halifax. The workshop, on the "nuts and bolts" of personnel administration, was designed for personnel clerks, personnel technicians, junior personnel assistants, and newly appointed personnel officers. It covered such topics as: recruitment, job specification and job evaluation, performance appraisal, labor relations, pay and benefits administration, and personnel procedures.

Central

Program arrangements for the 1977 Central Region Dakota Conference in Bismarck, North Dakota, May 22-25, have been set.

The conference title, "The New Basics," is reflective of the assimilation of elements of personnel administration which were thought to be new and foreign some short years ago and today have become very basic to the public personnel administrators working life.

Keynote speaker for the Conference is **John W. Boyer, Jr.**, professor of industrial relations, University of Minnesota at Duluth, who will speak on the Conference title, "The New Basics."

Gerald Andrews, commissioner of administration, State of South Dakota, will head a panel on the "Freedom of Information vs. Right to Privacy" issue. Included on the panel are **Allen Olson**, attorney general, State of North Dakota; **Gene Carr**, North Dakota Newspaper Association; and **Joe Stec**, deputy regional director of the U.S. Civil Service Commission.

Other speakers on the program include **R. Elliott Scarce**, director of personnel, St. Louis, who will look "Backwards and Forward" at the business of public personnel administration; and **Alice Kirby**, assistant director, Illinois State Affirmative Action Office, will head a panel on "Selection and Affirmative Action/Report From IPMA Assessment Council."

Sam Baker, personnel administrator, City of Pontiac, Michigan, will head a panel discussion on the "Future of Labor Relations in the Public Service"; **Jane Cole**, deputy director of personnel, City of Chicago, will speak to a general session on "Proactive Personnel Reorganization" reflecting the experience in the City of Chicago; **Bill Stipek**, classification and pay administrator, City of Kansas City, will head a panel on "Grievance Procedure Technology"; and **Jack Anderson**, director, IPP Division, Civil Service Commission, will head a panel on "Measuring Productivity in Government."

Robert C. Garnier, president of IPMA, will address a general session on the topic of "Today's Public Servant Image, or, Could You Really Encourage Your Son or Daughter to Pursue Public Service as a Career." A panel on the "IPMA Reorganization Proposal" will be headed by **Laurence Harkness**, director of administration, University of Missouri Medical School at Kansas City. **Thomas A. Tyler**, director, IPMA

ager, Detroit Regional Office, Michigan Department of Civil Service; and Garnier will participate in the panel discussion.

Robert Roeder, Indiana State Personnel director, will head a panel discussion on "Implementing and Maintaining Employee and Supervisory Training Programs." **Douglas McInerney**, associate director, Bureau of Inter-Departmental Personnel Programs, Civil Service Commission, will address a general session on "Merit Standards Review," currently being conducted by IPP. **Chuck Reott**, director of personnel, City of Madison, Wisconsin, will head a panel on "Classification Techniques;" and **William Boys**, Director of Personnel, State of Illinois, will head a panel on "Work Schedules—Flexibility, Four Day Work Week, Job Sharing." **Barbara Sundquist**, director, Minnesota Merit System, will head a panel on "Modern Approaches to Fringe Benefits and Compensation."
