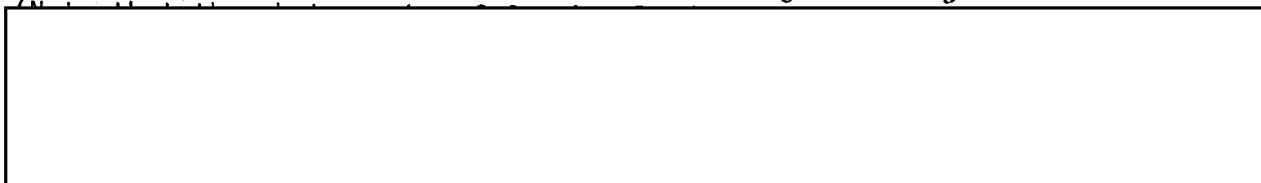

SUBJECT : Preparation for Discussion with Mrs. Rosalynn Carter  
Concerning Her Latin American Trip

1. Action Requested: That you ascertain from Mrs. Carter whether or not the CIA briefing prepared by CIA under the auspices of A/NIO/LA was adequate to meet her needs and how such briefings could be improved in the future.

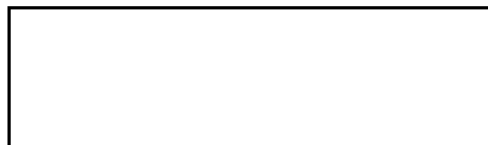
2. Background: At the request of Mr. Robert Pastor of the National Security Council Staff, I arranged to have the Office of Regional and Political Research (ORPA), the Office of Economic Research (OER), and the Central Reference Service (CRS) prepare a series of briefing papers to provide Mrs. Rosalynn Carter with the necessary background information on the countries she planned to visit in Latin America, the personalities she was likely to encounter, and the important issues likely to be raised with her. I am attaching a copy of the briefing book we gave Mrs. Carter.

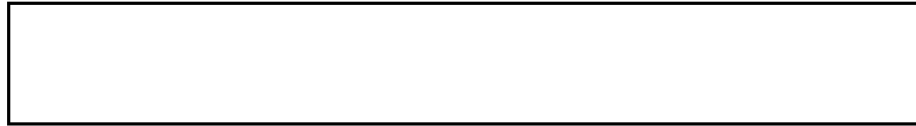
