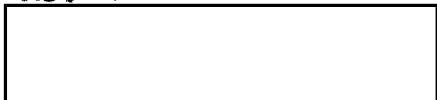

Dear Mr. Schamiloglu:

This is in response to your letters dated 26 October and 12 November 1975, and 5 August 1976.

We have completed a thorough search of our records in response to your request, and were able to locate the documents discussed below. These have been carefully reviewed, and our determinations are as follows.

The following documents are being withheld in their entirety. The applicable exemptions are given with each document cited, and are explained further below.

The Privacy Act subsections cited above apply as follows:

(j)(1), in this case, applies to polygraph records; documents or segregable portions of documents, release of which would disclose intelligence sources or methods, including names of Agency employees and organizational components; and, documents or information provided by another Federal agency;

(k)(1) applies to information and material properly classified pursuant to Executive Order 11652; and,

(k)(5) applies to investigatory material compiled solely for the purpose of determining suitability, eligibility, or qualifications for Federal civilian employment, or access to classified information, release of which would disclose a confidential source.

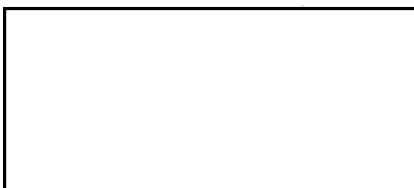
In addition, items annotated with the word "Privacy" were segregated or denied in order to preserve the privacy of other individuals, consistent with the specific intent of the Privacy Act itself.

As specified in the Privacy Act, I am advising you of your right to appeal the exemption decisions noted above, by addressing your appeal to the undersigned. I will forward your appeal to the appropriate senior officials.

Information was surfaced, for example as reflected in document #32, that you wrote to former Director Dulles on 22 June 1954 with two articles attached entitled "What is the Soviet System and How to be Victorious Over It" and "The Story of a Man Who Returned from Hell." Neither the letter nor the articles were found in the search of our records.

In addition to the above, we surfaced another document originated by the Immigration and Naturalization Service. This document has been referred to the INS for their determination and direct reply to you.

We wish to apologize for the length of time it has taken to complete the processing of your request. We have been veritably inundated over the past months with a large number of similar request. We could only do our best, accordingly to apportion our time and efforts in a manner calculated to satisfy as many of our requesters as possible. We thank you for your patience and consideration.

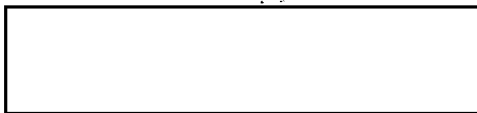
