1. I saw General Wedemeyer on 28 December and briefed him on the information available to this Agency on [redacted]

[redacted] I informed General Wedemeyer that we had no particularly useful information on the witnesses whose names he had given us but we thought [redacted] might be additional witnesses who could be helpful. I said I was very sorry that our Agency survey had not brought up more positive or helpful information. General Wedemeyer said he was most appreciative and he felt it was most helpful and he had hated to put us to the trouble of looking into this matter. I assured him that Mr. Dulles was only too glad to do what he could and that we would be glad to follow up any other points he could think of.

2. I suggested I might talk over our information with his lawyer and he said he would greatly appreciate it if I would talk both to Mr. Roger Robb, his lawyer, and General Maddox. He offered me his entire basic file in the case and I said I would have it checked to see if it offered any further leads.
