You may remember that in connection with the Kersten amendment, it was agreed that if some suggested statutory language could be agreed upon, it might be informally presented to the House Foreign Affairs Committee.

I understand that [ ] from CIA, Hoopes from Defense, and Cox from our Staff are meeting this afternoon to see if appropriate language can be drafted. If they agree, presumably, they will get MSA views. Finally, [ ] may discuss the matter with you in order to get your judgment, both on the language and on tactics.
