2. PROJECTS UNDER CONSIDERATION BY THE NSC

A. ITEMS SCHEDULED ON AGENDA FOR THE 94th NSC MEETING ON WEDNESDAY, JUNE 13, 1951:

THE SITUATION IN THE FAR EAST

Scheduled for discussion as Item 1 in the light of an oral briefing by the Chairman, JCS, on the military situation in Korea.

NSC DETERMINATIONS UNDER SECTION 1302, THIRD SUPPLEMENTAL APPROPRIATION ACT, 1951

(NSC 111 and Annexes Nos. 1 and 2 to NSC 111; NSC Action No. 479)

A proposed Item 1 in General Exception under Section 1302, prepared jointly by the Senior NSC Staff and the Special Committee on East-West Trade, was submitted for Council consideration as NSC 111. Specific country reports on trade between the Soviet bloc and Austria and Norway, respectively, were submitted as Annexes Nos. 1 and 2 to NSC 111. Further statistical studies in support of these Annexes are to be circulated prior to the Council meeting.

The Secretary of Commerce, the Economic Cooperation Administrator and the Chairman, Export-Import Bank, have been invited to participate in Council action on this item. Scheduled for consideration as Item 2. (See related project in Sections 3-A and C.)

APPRAISAL OF FOREIGN ECONOMIC INTELLIGENCE REQUIREMENTS, FACILITIES AND ARRANGEMENTS RELATED TO THE NATIONAL SECURITY

(Memos for NSC from Executive Secretary, same subject, dated February 7, 1950 and June 1, 1951; NSC Action No. 282)

In approving the proposal by the Acting Chairman, NSRB, in the reference memo of February 7, the NSC directed (NSC Action No. 282) the CIA, in collaboration with the Government agencies concerned, to organize and conduct a study of foreign economic intelligence requirements, facilities and arrangements related to the national security, and based on the finding of this study, to prepare for Council consideration and action a comprehensive plan for satisfying the foreign economic intelligence requirements of the national security and for a coordinated interagency effort to this end based on a definite allocation of responsibilities among the agencies concerned.

Report by CIA submitted by the reference memo of June 1 for Council consideration of the proposed NSCID on "Coordination and Production of National Intelligence" and the proposed letter to non-IAC

departments and agencies, attached as Tabs B and C respectively. The Attorney General, the Secretary of Commerce and the Economic Cooperation Administrator have been invited to participate in Council action on this subject. Scheduled for consideration as Item 3.

U. S. CIVIL AVIATION POLICY TOWARD THE USSR AND ITS SATELLITES
(Progress Report, dated June 5, 1951, by the Under Secretary of State, on NSC 15/3)

The reference progress report has been circulated for Council information. The Secretary of Commerce, the Economic Cooperation Administrator and the Chairman, Civil Aeronautics Board, have been invited to participate in Council action on this item. Scheduled for information as Item 4.

U. S. POLICIES AND PROGRAMS IN THE ECONOMIC FIELD WHICH MAY AFFECT THE WAR POTENTIAL OF THE SOVIET BLOC
(Progress Report, dated June 7, 1951, by the Under Secretary of State on NSC 104/2)

The reference progress report has been circulated for Council information. The Secretaries of the Interior, Agriculture and Commerce, the Economic Cooperation Administrator and the Director, Bureau of the Budget have been invited to participate in Council action on this item. B. ITEMS AWAITING SUBSEQUENT NSC CONSIDERATION

THE POSITION OF THE UNITED STATES WITH RESPECT TO IRAN
(NSC 107/1; NSC 107; NSC Action No. 454; Memo for NSC from Executive Secretary, same subject, dated March 26, 1951; Progress Reports by the Under Secretary of State on NSC 107, dated May 2, and May 31, 1951; SE-6; NIE-6)

In adopting the reference report at its 87th meeting, the Council directed the NSC Staff to review the statement of policy in NSC 107, if the President approved it, whenever the situation in Iran had clarified sufficiently to warrant such review, and in any event not later than July 1, 1951. Accordingly, in the light of the current situation and the reference progress and CIA reports, the Senior Staff, on May 3, agreed that the State, Defense and CIA members of the Senior Staff, consulting with other departments and agencies as desirable, should explore the need for a revision of NSC 107 in the light of the current situation and report their findings to the Senior NSC Staff. A draft revision of NSC 107 was approved by the Senior Staff and submitted to the Council as NSC 107/1 on June 6. The Senior Staff directed the Staff Assistants to prepare, as early as possible, a revision of the Staff Study in NSC 107, including an evaluation of oil requirements in relation to Iran in the light of information being developed in connection with the NSC 97 Series.

NSC 107/1 will be scheduled on the agenda of an early Council meeting. (See same subject, Section 3-B, and NSC 97 project, Section 4).

UNITED STATES POLICY TOWARD SPAIN
(NSC 72/5)

The reference report, a redraft of the statement of policy on Spain in NSC 72/4, prepared by the Department of State, has been submitted for Council consideration and will be scheduled on the agenda of an early Council meeting.

/PRIORITY PROJECT/

Memorandum by the Senior State Member on the subject transmitted by the reference memo and considered by the Senior Staff on December 29, when it was agreed that an initial draft report should be prepared by State and that CIA should furnish an intelligence estimate of local attitudes and conditions which affect protection of our interests and the realization of our objectives. On February 23 the Senior NSC Staff agreed that this project should be completed as a matter of priority. CIA estimate circulated as NIE-26. Awaiting initial draft report from State. (See also related area projects in this section.)

CONDITIONS FOR A PEACEFUL SETTLEMENT WITH THE USSR

/PRIORITY PROJECT/

(Records of Senior NSC Staff Meeting, February 23 and May 24; NSC 79; Memo for NSC from Executive Secretary subject: "United States and Allied Objectives in the Event of Global War", dated September 6, 1950)

On February 23 the Senior NSC Staff agreed that the NSC 79 project on United States and allied war objectives should be completed in two sections and that the section on the above subject, including a plan for reduction and regulation of armaments and armed forces, should be completed as a matter of priority. On May 24 the Senior Staff agreed that the completion of this project would provide an important background for obtaining popular support for U. S. national security policies. Awaiting report by the State, Defense and JCS members. (See also related project above; NSC 79 below; "Joint Review" in Section 5; and "U. S. Objectives" item in Section 1.)

UNITED STATES AND ALLIED WAR OBJECTIVES IN THE EVENT OF GLOBAL WAR
(NSC 79; Memo for NSC from Executive Secretary, same subject,
dated September 6, 1950)

JCS memo (NSC 79) circulated for Council information and referred to the Staff for use in the preparation of a report. The Senior Staff designated an ad hoc group to draft a report to include both a statement of war objectives in the event of global war, and such related questions as a statement of the conditions that the U. S. would be willing to accept for a peaceful settlement with the USSR and its satellites. At the initial meeting of the ad hoc group under the chairmanship of the State member on October 6, the form and content of a response to the problems posed by NSC 79 were discussed and agreed upon.

On February 23 the Senior Staff agreed that this project should be divided as follows: (1) a statement of U. S. and allied war objectives in the event of a global war; and (2) a statement of the conditions the U. S. would be willing to accept for a peaceful settlement with the USSR, including a plan for the reduction and regulation of armaments and armed forces. Awaiting initial draft by the State Policy Planning Staff of the project listed under (1) above. (See also related projects above, "Joint Review" in Section 5, and related item in Section 1.)

PROPOSED NSC STUDY OF USE OF CIVILIAN MANPOWER OF NON-SOVIET NATIONS FOR PRODUCTION OF GOODS AND SERVICES
(Memo for Senior NSC Staff from Executive Secretary, subject: "Proposed NSC Study of Use of Foreign Manpower for Production", dated March 29, 1951; Memo for Senior NSC Staff from Executive Secretary, same subject, dated April 16, 1951)

Memos by the Acting Senior NSRB Member and by the Senior ODM Member, transmitted by the reference memos of March 29 and April 16, respectively, were considered by the Senior Staff on April 17. It was agreed that ODM should undertake the preparation of a report on the subject for consideration by the NSC Staff, along the lines proposed by ODM in the report attached to the reference memo of April 19. The Staff further agreed to the inclusion of NSRB and Mr. Harriman's Office among the agencies to be consulted by ODM. Awaiting report from Senior ODM Member. (See related project in Section 3-B.)

THE POSITION OF THE UNITED STATES WITH RESPECT TO INDOCHINA
(NSC 64/1; Memo for Senior NSC Staff from Executive Secretary,
same subject, dated January 4, 1951)

At the request of the Secretary of Defense the views of the JCS on the subject (NSC 64/1) were circulated for Council information and referred to the NSC Staff for use in the preparation of a report for Council consideration. On December 27, the Senior Staff directed the Staff Assistants to prepare, as a matter of urgency, a draft report on the immediate steps the United States should take to meet the critical situation in Indochina. Draft report by Staff Assistants submitted to Senior Staff by the reference memo. On January 8, the Senior Staff discussed the subject in the light of the importance of Indochina to the security of Southeast Asia and the security of the United States. To be considered further at a later Senior Staff meeting.

JAPANESE PEACE TREATY
(NSC 60/1)

On September 15 the Senior Staff agreed that this subject should be a continuing project and that accordingly the Senior State Member should keep the Senior Staff informed on any security policy issues which may arise, with a view to further consideration of the subject.

PROPOSED TRANSFER OF THE POINT IV PROGRAM FROM THE DEPARTMENT OF STATE TO THE ECONOMIC COOPERATION ADMINISTRATION
(NSC 110)

Memorandum on the subject from the Bureau of the Budget (NSC 110) was referred by the President to the NSC with the request that the Senior NSC Staff prepare a recommendation on the subject for Council consideration as advice to the President. At the direction of the President, the Secretaries of the Interior, Agriculture and Commerce, the Federal Security Administrator and the Economic Cooperation Administrator will participate in this Council project and have been requested to designate representatives to join with the Senior NSC Staff for this purpose. The President also expressed the desire that the views of the Rockefeller Committee be obtained in connection with the preparation of the above report. The Department of State and the Economic Cooperation Administration have been requested to submit brief factual statements on the Point IV Program and the ECA technical assistance program, respectively for Senior Staff information in this connection. The following officials have been designated to join with the Senior NSC Staff in

(NSC Action No. 487 a; Memo for NSC from Executive Secretary, same subject, dated June 1, 1951; Memo for NSC from Executive Secretary, subject: "Review of the Current World Situation and Ability of the Force Being Maintained to Meet United States Commitments", dated April 26, 1951)

By the reference NSC Action the Council directed the Senior NSC Staff to prepare, with the assistance of appropriate executive departments and agencies, the following reports for Council consideration: (1) A review of the status of the programs described in NSC 68/4, including an analysis of any difficulties which may be impeding or preventing their successful execution; and (2) Recommendations regarding any revisions or modifications of the policies and programs contained in NSC 68/4. To be scheduled for consideration on the agenda of an early Senior NSC Staff meeting. (See also related projects below and in Sections 1 and 5.)

THE EFFECT UPON UNITED STATES OBJECTIVES, CAPABILITIES, AND COMMITMENTS OF THE MILITARY BUDGET FOR FY 1952
(NSC 68 Series; NSC Action No. 393)

The subject was discussed on May 8 in the light of an oral presentation by Mr. Garlock of the Department of Defense, and as relative to current NSC projects.

Subsequently, on May 10, the problems involved in meeting production schedules for military materiel were discussed in the light of informal comments by Mr. Fisher of the Office of Defense Mobilization. It was agreed that Mr. Fisher should be invited to discuss the subject at greater length at such time as the relevant data become available for presentation to the Senior Staff.

It was also agreed that the Executive Secretary should arrange at an early date for a similar presentation with respect to the status of the MDAP programs. (See also related projects in Sections 1 and 5, and above in this section.

PRIORITY PROJECT

On May 31 the Senior NSC Staff directed the Staff Assistants to prepare, as early as possible, a revision of the NSC Staff Study in NSC 107, including an evaluation of oil requirements in relation to Iran in the light of information being developed in connection with the NSC 97 Series. Awaiting initial draft revision by State. (See same subject, Section 2-B and NSC 97 project, Section 4.)

CONGRESSIONAL PUBLICATION OF INFORMATION OF ADVANTAGE TO FOREIGN GOVERNMENTS

(Memo for NSC from Executive Secretary, same subject, dated May 16, 1951; NSC Action No. 478)

Memorandum on the subject by the NSC Representative on Internal Security, transmitted by the reference memo, was discussed at the 2nd NSC Meeting. The Council directed the Senior NSC Staff, by the reference action, with the assistance of the Interdepartmental Committee on Internal Security, to prepare recommendations on the subject for Council consideration in the light of the discussion. On May 29, the Senior Staff together with Mr. Murphy, of the White House Staff, the NSC Representative on Internal Security and Mr. Whearty, of the Department of Justice, considered the subject on the basis of the enclosure to the reference memorandum and directed the Staff Assistants to prepare a draft recommendation on the subject, in the light of the discussion, for consideration by the Senior Staff. Initial draft, circulated to Staff Assistants June 6, to be considered at an early meeting.

Progress Report, dated November 14, 1950, on NSC 28/1 and NSC 32/1; NSC 88; Memo for Senior NSC Staff from Executive Secretary, subject: "U.S. Courses of Action in the Event the Soviets Attempt to Close the Baltic", dated March 26, 1951; Record of Senior Staff Meeting on April 3, par. 3)

On December 13 the Senior NSC Staff directed the Staff Assistants to prepare a draft revision of NSC 28/1 for consideration by the Senior Staff.

On October 17, 1950, NSC 88, "U.S. Courses of Action in the Event the Soviets Attempt to Close the Baltic", was circulated for Council information and referred to the NSC Staff for preparation of a report

for Council consideration. In view of recommendations made by the Staff Assistants in the reference memo of March 26, the Senior Staff agreed on April 3 that a statement of policy and a staff study on the subject of NSC 88 should be incorporated in the draft report on "The Position of the United States With Respect to Scandinavia", and that completion of this project should be expedited. Awaiting initial draft report by State.

UNITED STATES POLICY WITH RESPECT TO BERLIN AND EASTERN GERMANY

(NSC 89; NSC 73/4, par. 42; Memos for NSC from Executive Secretary, subject: "Additional Airlift to Support the Far East", dated September 27 and November 20, 1950; NSC Action No. 368; Memo for Senior NSC Staff from Executive Secretary, same subject, dated October 31, 1950; Memo for Senior NSC Staff from Executive Secretary, subject: "Courses of Action in the Event East Germany Imposes a Blockade in Berlin", dated February 16, 1951; Memo for Senior NSC Staff from Executive Secretary, subject: "United States Policy With Regard to a Possible New Berlin Blockade", dated March 27, 1951; NIE-4)

At its 69th Meeting, the Council noted the reference memo of September 27, and the fact that the situation presented therein would be taken into consideration in the studies on the Berlin blockade referred to in par. 42 of NSC 73/4. Memoranda on the subject by the Deputy Under Secretary of State and the Secretary of Defense were circulated for Council information as NSC 89, and referred to the NSC Staff for use in connection with this staff project. JCS study on airlift capabilities circulated to Senior Staff by the reference memo of October 31. Subsequent memo by the Deputy Secretary of Defense (reference memo of November 20) circulated for Council information and referred to the Staff for consideration in connection with this project. Views of the JCS on "Courses of Action in the Event East Germany Imposes a Blockade in Berlin" circulated by the reference memo of February 16 to the Senior Staff for consideration in connection with this project upon the recommendation of the Secretary of Defense. NIE-4, issued by CIA, relates to the above subject.

On February 23 the Senior Staff noted that the JCS views would be taken into account in the early completion of a draft report on "U.S. Policy With Respect to Berlin and Eastern Germany" now under preparation in the Department of State in collaboration with the Department of Defense. Report by State circulated by reference memo dated March 27, considered by the Senior Staff on April 3 and referred to the Staff Assistants for revision in the light of the discussion. Awaiting initial draft by ad hoc group of Staff Assistants.

Letter by the Secretary of Defense to the President on the subject, and the President's reply, referred by the President to the Council, circulated as NSC 106 for Council information, and referred to the Senior Staff for preparation of recommendations on the subject for consideration by the Council, the Secretary of the Treasury, the Director of Defense Mobilization, and the Economic Cooperation Administrator at an early Council meeting.

On March 15 the Senior Staff discussed the reference report and referred it to the Staff Assistants for use in the preparation of a draft report for consideration by the Senior Staff. Initial draft in preparation by ad hoc group of Staff Assistants with the advice and assistance of a special group from the Defense Department. Awaiting initial draft from ad hoc group of Staff Assistants.

UTILIZATION OF MANPOWER OF OTHER NATIONS FOR MILITARY PURPOSES

(NSC 108 and memo for all holders of NSC 108, dated April 24, 1951; Memo for NSC from Executive Secretary, same subject, dated May 8, 1951; NSC Action No. 472)

At the suggestion of the Senior State Member, the Senior NSC Staff on December 12 agreed to designate an ad hoc group under the chairmanship of a JCS official and with officials from State, NSRB, Mr. Harriman's office, and CIA, to prepare a draft report on the subject.

The report by the ad hoc committee was considered and amended by the NSC Staff for submission to the NSC as NSC 108. JCS views circulated by the reference memo. At its 91st Meeting the NSC referred NSC 108 to the NSC Staff for reconsideration. On May 17 the Senior Staff referred NSC 108 to the Staff Assistants for revision in the light of the discussion. To be scheduled for discussion at an early meeting of the NSC Staff Assistants. (See related civilian manpower project in Section 3-A)

C. OTHER CURRENT NSC STAFF PROJECTS

NSC DETERMINATIONS UNDER SECTION 1302, THIRD SUPPLEMENTAL APPROPRIATION BILL, 1951

(NSC 111 and Annexes Nos. 1 and 2 to NSC 111; Memo for Special Committee, same subject, dated May 28, 1951, with copies for Senior NSC Staff; Record of Senior NSC Staff meeting on May 22, 1951, Item 2; NSC Action No. 479)

On May 25, 1951, the Special Committee on East-West Trade discussed and agreed upon procedures for staff work on the subject, in the event the President signed the Third Supplemental Appropriation Bill, 1951, as he did on June 2. The procedure, as follows, was based upon the discussion at the Senior Staff meeting on May 22, and the subsequent discussion at the Council meeting on May 23, 1951:

1. The initial Council determinations under Section 1302 should consist of reports on four or five selected countries or groups of countries, as thoroughly documented as time will permit, and a general exception for all others.
2. The reports will be unclassified to the greatest extent possible with due consideration to the requirements of security.
3. A drafting group, composed of the State, Defense, Commerce and ECA members of the Special Committee, should prepare the above reports, with discretion as to the selection of the countries and as to the form and content of the reports.
4. The initial reports should be submitted by the drafting group for joint consideration by the Senior NSC Staff and the Special Committee, with the view to Council action thereon no later than its regularly scheduled meeting on June 13, 1951.

The Special Committee also agreed that the Export-Import Bank should be invited to have representation on the Special Committee for the staff work in connection with Section 1302.

An Interim General Exception under Section 1302 of the Third Supplemental Appropriation Act, 1951, prepared jointly by the Senior NSC Staff and the Special Committee on June 8, was submitted as NSC 111 for Council consideration. Country reports on trade between Austria and Norway, respectively, and the Soviet Bloc were circulated separately by Annexes Nos. 1 and 2 to NSC 111, respectively.

Additional country studies are in preparation by the drafting group in anticipation of Council action upon the "Instructions" contained in NSC 111. Awaiting additional country studies by the drafting groups. (See also Section 2-A.)

in consultation with other interested agencies, a plan for the provision of essential Federal guidance and assistance to the States in organizing reserves to perform State and local security functions when the National Guard is ordered into active military service, this plan to include any necessary Federal legislation.

Report by the Chairman, NSRB, circulated for Council information as NSC 96/1 and referred to the NSC Staff for use in the preparation of a report for Council consideration. On April 12, the Senior Staff discussed NSC 96/1 and referred it to the Defense, JCS and NSRB Staff members together with officials from the Department of Justice, the Bureau of the Budget, and the Federal Civil Defense Administration, for use in the preparation of a report for Senior Staff consideration.

Draft outline, prepared by the Executive Secretary, transmitted to the above staff group by the reference memorandum, and discussed at a meeting on May 14. With some modifications, the outline was adopted as a working guide and the proposed assignments were accepted. Civil Defense drafts received on May 16; Justice, on June 2. Awaiting other drafts assigned to Defense.

RELEASE OF INFORMATION REGARDING NEW WEAPONS

(Memo for NSC Consultants and AEC Representative, from Executive Secretary, same subject, dated July 5, 1950)

At the direction of the President, the Council and the Chairman of the Atomic Energy Commission undertook a consideration of the general problem of weapons information, including atomic weapons, in order to make appropriate recommendations to the President on the subject. A draft report, prepared by the Executive Secretary in accordance with the discussion at a meeting on June 22, 1950, has been circulated to the NSC Staff and a representative of the AEC by the reference memo. Awaiting redraft of this report by Defense.

5. CANCELLED PROJECTJOINT REVIEW OF POLITICO-MILITARY STRATEGY

(NSC Actions Nos. 393-b, 424 and 487; NSC 68/4; NSC 100; Memo for NSC from Executive Secretary, subject: "Recommended Policies and Actions in Light of the Grave World Situation", dated January 16, 1951; Memo for NSC from Executive Secretary, subject: "United States Objectives and Programs for National Security," dated June 1, 1951)

The President directed (NSC Action No. 393-b) the Secretaries of State and Defense to undertake a joint review of the politico-military strategy of this Government with a view to increasing and speeding up the programs outlined in NSC 68/4 in the light of the present critical situation, and to submit to the President as soon as possible appropriate recommendations through the NSC.

At its 81st Meeting the Council discussed a report by the Chairman, NSRB, on "Recommended Policies and Actions in Light of the Grave World Situation" (NSC 100) and noted the reference by the President of NSC 100 to the Secretaries of State and Defense for consideration in connection with the joint review of the politico-military strategy of this Government.

At its 93rd Meeting (NSC Action No. 487b) the Council noted the President's amendment of the second sentence of his previous directive (NSC Action No. 393-b, above) to the Secretaries of State and Defense to read: "However, since this paper points out that the programs contained in it are not final, I hereby direct the Secretary of State and the Secretary of Defense to maintain a continuing joint review of the politico-military strategy of this Government."

Accordingly, in the light of the above action by the President, and of the Council's directive to the Senior NSC Staff with respect to the NSC 68/4 series (NSC Action No. 487a), this project is herewith removed from the list of pending Council projects.
