



II. PROJECTS AWAITING CONSIDERATION BY THE NSC

1. SIGNIFICANT WORLD DEVELOPMENTS AFFECTING U. S. SECURITY

The subject is scheduled for discussion on December 3, in the light of an oral briefing by the Director of Central Intelligence.

2. BERMUDA CONFERENCE

An oral report by the Secretary of State on probable developments at the forthcoming Bermuda Conference is scheduled to be noted at the Council meeting on December 3.

3. REAPPRAISAL OF THE MILITARY EFFECT OF A RELAXATION OF CONTROLS ON TRADE WITH THE SOVIET BLOC IN STRATEGIC RAW MATERIALS

Origin: At its meeting on November 19, 1953 in connection with its action on NSC 171 ("Indonesia"), the Council requested the Department of Defense to make, before January 1, 1954, for Council consideration, a reappraisal of the military effect of a relaxation of control on trade with the Soviet bloc in strategic raw materials where such trade might result in a net advantage to the free world through increased political and economic stability (NSC Action No. 962-b).

<u>Current Status</u>: The above Council action is scheduled for reconsideration at the Council meeting on December 3 on the basis of oral remarks by Mr. Cutler.

Crigin: At its meeting on November 19, the Council amended and adopted, subject to review by the Council early in 1954, the report contained in NSC 172, as interim defense mobilization planning assumptions (NSC Action No. 963). The report as amended and approved by the President was circulated as NSC 172/1.

<u>Current Status</u>: Awaiting review of the interim defense mobilization assumptions contained in NSC 172/1 by the Council early in 1954.

Origin: A letter from the Secretary of Commerce on the subject was circulated to the Council for information by the reference memo of October 20 and referred to the Planning Board for study and for the preparation of recommendations for Council consideration.

Current Status: Awaiting a report on the subject by the special committee constituted at the Planning Board meeting on October 28, and consisting of officials designated by Defense, Commerce and AEC, assisted by Dr. Beckler as scientific adviser and Mr. Farley as executive secretary. Tentatively scheduled for December 10.

Origin: Revised paragraphs 20-e(1) and (2) of NSC 159/4 as approved by the President on November 24, 1953 (reference memo of November 24) state that the following elements of the continental defense program contained in NSC 159/4 require further consideration before action by the Council: (1) Additional protective measures at selected industrial and governmental facilities of a highly critical nature; (2) Additional selective counterintelligence coverage by the FBI of Soviet bloc diplomatic representatives in the United States whose activities are suspected to extend beyond the scope of their normal diplomatic assignments. Council on November 23 also agreed (3) that a thorough study should be made as to the comparative advantage to the United States and the USSR which would result from an international agreement restricting the use of the diplomatic pouch solely to the transmittal of documents (NSC Action No. 966-h).

Current Status: Awaiting: (a) development by ODM of the program referred to in (1) above, with cost estimates; (b) development by Justice of the program referred to in (2) above, with cost estimates (tentatively scheduled for Planning Board consideration on December 15); (c) preparation by a special committee of the Planning Board (consisting of representatives of State, Treasury, Defense, Justice and CIA) of a study pursuant to (3) above.

Origin: At its meeting on October 1 the Council (a) reaffirmed the statement of policy on the subject in NSC 160/1, pending review by the Council in 30 days; and (b) requested the Director of FOA, in collaboration with State and Defense and the Bureau of the Budget, to prepare for Council information in 30 days a revised financial appendix on the subject.

Current Status: Awaiting revision by an interdepartmental working group of the Financial Appendix of November 17 (reference memo of that date) prior to submission to the Council and review by the Council of NSC 160/1 pursuant to NSC Action No. 919-a. Tentatively scheduled for December 10.

2. FY 1955 BUDGET CONSIDERATIONS
Ref: Council - NSC 161, No. 11; NSC Action Nos. 930
and 945

Origin: The Council at its meeting on October 13:

(a) discussed the subject on the basis of oral presentations by the Director, Bureau of the Budget, the Chairman, AEC, the Director, FOA, the Secretary of Defense and Assistant Secretary of Defense McNeil; and (b) requested the Secretary of Defense, the Director, FOA, and the Chairman, AEC, to submit to the Council at its meeting on October 29 interim reports of estimated FY 1955 expenditures for their respective programs, to the extent that they had then been reviewed and coordinated within each agency in the light of the Council's discussion (NSC Action No. 930).

Current Status: Awaiting final consideration of the subject at the Council meeting on December 15 based upon a report by the Secretary of Defense pursuant to NSC Action No. 945-a and further reports by the Director, FOA, and the Chairman, AEC. (See also related project just below.)

3-CONTINENTAL DEFENSE Council - NSC 159/3; 159/4; NSC Action Nos. 915

Origin: The President on September 25, 1953 approved NSC 159/4 as a guide to the respective departments and agencies in implementing their programs during FY 1954 and in developing their programs for future years, subject to (1) On December 15, a more precise definition by the Department of Defense of certain programs and their phasing, and the indentification of the portion of Defense Départment effort and costs related to such defined programs; and (2) Before December 15, determination by the Council of the manner of financing the recommended integrated programs for continental defense in FY 1954 and future years, in proper relation to the over-all budget and taking into account FY 1955 budget submission by the departments and agencies (Note: The dates in (1) and (2) above were changed from November 15 and December 1 respectively by NSC Action Nos. 946 and 966).

Current Status: Awaiting (a) a report on December 15 by the Department of Defense pursuant to (1) above in conjunction with its FY 1955 budget presentation (see project just above); (b) by December 15 a determination by the Council of the manner of financing the recommended integrated programs for continental defense pursuant to (2) above; and (c) an estimate by the JCS of a reasonable patrolling program for the seaward extension of the Southern Canadian early warning system, pursuant to NSC Action No. 966-f.

4. UNITED STATES OBJECTIVES AND COURSES OF ACTION WITH RESPECT TO FORMOSA AND THE CHINESE NATIONAL GOVERNMENT Ref: Council - NSC 146/2; NSC Action No. 953

Origin: On November 5, 1953 the Council adopted the statement of policy contained in NSC 146/2 and agreed that subparagraph 12-a thereof would be subject to review in the light of recommendations by the Department of Defense regarding Chinese Nationalist force levels and the rate of military assistance to be provided the Chinese National Government beyond Fiscal Year 1954, (see footnote to paragraph 12-a).

Current Status: Awaiting recommendations from the Secretary of Defense. Tentatively scheduled for Council consideration December 23.

5. ORGANIZATION OF THE GOVERNMENT WITH RESPECT TO INTERNAL SECURITY AND CONTINENTAL DEFENSE FUNCTIONS

Origin: The Council on August 6, 1953 (NSC Action No. 873-d) noted that the President requested Mr. Flemming to establish a special task force to study and make recommendations on improving the organization of government with respect to internal security functions and with respect to the continental defense functions covered in Part VI of NSC 159.

Current Status: Awaiting recommendations from Mr. Flemming. Tentatively scheduled for Council consideration December 31. (See also related projects above and in Section III).

6. <u>U.S. CONTROLS ON TRANSACTIONS WITH COMMUNIST CHINA</u>
Ref: <u>Council</u> - NSC 152/3; NSC Action No. 952-b;
NSC 166/1

Origin: On November 5, in connection with its adoption of NSC 166/1, the Council agreed that the Economic Defense Advisory Committee should review, in the light of the discussion at that meeting, current policy in NSC 152/3 with respect to U. S. controls on transactions with Communist China, and report to the Council the results of such review.

Current Status: Awaiting a report by the Economic Defense Advisory Committee. Tentatively scheduled for Council consideration January 7. See also related project in Section II above.

7. A NATIONAL PETROLEUM PROGRAM Ref: Council - NSC 97/6

Origin: Paragraph 11-a of NSC 97/6 calls for a review by the Council not later than December 31 of the goal of a tanker reserve of 175-T-2 equivalent laid-up tankers; and paragraph 16-c calls for a report by January 1, 1954 to the Council on progress with respect to the development of a program for construction by private industry of two pipelines for crude oil transportation in wartime.

Current Status: Awaiting (a) a review by the Council not later than December 31 pursuant to paragraph 11-a of NSC 97/6 and (b) a progress report by ODM by January 1 pursuant to paragraph 16-c of NSC 97/6. Tentatively scheduled for Council consideration January 14.

8. ELECTRO-MAGNETIC COMMUNICATIONS Council - NSC 169; NSC Action Nos. 812, 840 and 934; Memo, July 14.

Origin: By the Council action of July 11 on the subject transmitted by the reference memo of July 14 the Director of ODM was designated as coordinating authority to prepare a Progress Report for submission to the Council or the Planning Board by January 1 as to the recommendation contained in paragraph 3 of the action with respect to the "Advancer" project (subsequently incorportated in NSC 169 as paragraph 3). By NSC Action No. 934-d of October 22 the Director of ODM was directed to report to the Council, in connection with his January report such information as may then be available as a basis for decision on the subject of expanding or discontinuing U.S. highfrequency psychological broadcasting.

Current Status: Awaiting report by the Director of ODM by January 1 pursuant to the above Council actions. Tentatively scheduled for Council consideration January 14.

CIVIL ADMINISTRATION OF THE RYUKYU ISLANDS, REMAINING UNDER U. S. JURISDICTION
Ref: Council - NSC 125/6, paragraph 4; NSC Action No. 965; Memo, August 7, 1953; Memos, subject, "The Japanese Treaty Islands", June 15 and August 7, 1953 Plan. Bd. - Memo, October 26, 1953; Record of Meeting, October 28

Origin: The Council on June 25 in connection with its action on "The Japanese Treaty Islands" (see NSC Action No. 824, para. 4 of NSC 125/6 and reference memo of August 7) agreed that the Secretary of Defense, in collaboration with the Department of State, the Bureau of the Budget, and other interested agencies, should recommend for Council consideration a policy on the civil administration of those Ryukyu Islands remaining under U. S. jurisdiction, which would reduce U. S. responsibility for such civil administration as rapidly as compatible with U. S. military requirements.

Current Status: Awaiting further study pursuant to NSC Action No. 965 by the Secretaries of State and Defense and report back to the Council prior to the end of December.

Origin: The Council on September 17 agreed that the Department of Justice, with the assistance of the IIC and the ICIS, should review existing internal security laws in their entirety with a view to submitting for Council consideration constructive proposals regarding possible legislation which might be introduced at the next session of Congress (NSC Action No. 910-b)

Current Status: Awaiting a further report by the Attorney General pursuant to NSC Action No. 968-g concerning internal security legislation, including consideration of the desirability of legislation outlawing the Communist Party of the United States.

11. U. S. POSITION WITH RESPECT TO THE REGULATION, LIMITATION AND BALANCED REDUCTION OF ARMED FORCES AND ARMAMENTS
Ref: Council - NSC 112 and 112/1; Progress Report dated January 19, 1953 by the Under Secretary of State on NSC 112; Memos, "Formulation of a United States Position with Respect to Regulation, Limitation and Balanced Reduction of Armed Forces and Armaments", February 17 and June 3, 1953; NSC Action Nos. 717-b, 899, 909 and 959

Origin: At its meeting on September 9, 1953, the Council adopted the recommendations contained in paragraphs 7-b and 8 of NSC 112/1 and agreed to recommend to the President that the Secretaries of State and Defense and the Chairman of the Atomic Energy Commission be appointed a special committee to review, as a matter of urgency, the current policy contained in NSC 112, with particular reference to the international control of atomic energy, and to report back to the Council their findings and recommendations. (NSC Action No. 899)

Current Status: Awaiting pursuant to NSC Action No. 959-a the results of the study by the Secretaries of State and Defense of the tentative proposals by the Chairman, AEC.

12. EFFECT ON NATIONAL SECURITY INTERESTS IN LATIN AMERICA OF POSSIBLE ANTI-TRUST PROCEEDINGS
Ref: Council - Memo, June 1, 1953; NSC Action No. 805

Origin: A report by the NSC Planning Board on the subject (reference memo for June 1) was considered by the Council on June 4, 1953 and it was agreed that in view of the adverse effects and national security interests
