## RAILROAD AND HIGHWAY BRIDGE THANH HOA, NORTH VIETNAM 1950N 10548E

- STRIKE DATA REPORTS THE RAILROAD AND HIGHWAY BRIDGE OVER THE SONG MA (RIVER) WAS STRUCK ON 3 APRIL 1965 BY THIRTY-ONE USAF AIRCRAFT, WHICH RESULTED IN 46 PERCENT DESTRUCTION OF THE SOUTHERN ROADWAY OF THE BRIDGE, DAMAGE TO THE NORTHERN ROADWAY, STRUCTURAL DAMAGE TO THE TRUSS AND RAILBED, AND CRATERING OF THE EASTERN APPROACH.
- TROJAN HORSE REVEALS A TWO-SPAN, THROUGH STEEL TRUSS COMBINATION RAILROAD AND HIGHWAY BRIDGE 2.5 NM NORTHEAST OF THANH HOA. STEEL TRUSS WORK APPEARS DISTORTED ON THE EASTERN END OF THE BRIDGE. THE SOUTHERN ROADWAY OF THE BRIDGE IS ALMOST COMPLETELY DESTROYED, AND THE NORTHERN ROADWAY IS 20 PERCENT DESTROYED. PROBABLE RECONSTRUCTION ACTIVITY IS NOTED AT THE BRIDGE'S EASTERN APPROACH. A WELL TRAVELED CUT OFF IS OBSERVED EXTENDING FROM ROUTE 1 TO THE FERRY CROSSING LOCATED 0.2 NM SOUTH OF THE BRIDGE; HOWEVER, NO VEHICLES OR FERRY IS NOTED IN THE VICINITY OF THE CROSSING.
- 3. A TOTAL OF FIVE MEDIUM AAA SITES, SIX LIGHT AAA SITES, EIGHT HMGAA SITES, AND FOUR UNOCCUPIED SITES ARE OBSERVED IN THE AREA OF THE BRIDGE, AS FOLLOWS:


