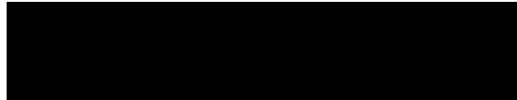

Remarks: Two excellent & helpful memos - Let's take them as a start, not a finish:




