EXPLANATION OF PROPOSED AMENDMENT OF SECTION 1034(a)

The proposal would amend \$1034 of the Code dealing with the non-recognition of gain on the sale or exchange of a residence to provide that the 18-month period for reinvesting the sales proceeds in a new residence will be tolled during the time an individual is employed on a permanent basis outside of the U. S. Many employers actively discourage transferred employees from buying homes abroad because of the problems dealing with home-ownership and disposal thereof. Consequently, it is very difficult for transferred employees who are sent abroad to comply with the 18-month period set forth in present \$1034.

PROPOSED AMENDMENT OF SECTION 1034(a)
DEALING WITH NON-RECOGNITION OF GAIN
ON SALE OR EXCHANGE OF RESIDENCE

Section 1034(a) is amended by inserting at the end thereof the following:

"The running of the eighteen-month period after the date of the sale of the old residence shall be suspended for any period during which the taxpayer's principal place of work is located outside the United States."
