

II caps THE DISSEMINATION OF SDS INTELLIGENCE INFORMATION

1. Description of the various types of information.

a. SDS reports are either complete translations of captured German and Russian documents, or are the collations of extract translations based on German and Russian documents.

b. The Industrial Card File cards are 5 x 8 mimeographed cards which contain specific items of industrial information, based on captured German and Russian documents, as well as information from numerous other sources. The following agencies contribute cards to the SDS for reproduction and dissemination: these cards are based on numerous sources, not only documents: A-2, AAF; ONI;  OMAM; Eurasian Br., ID; State Department; CIG, Doc Br.; a 50X1 CINCEUR. Cards are distributed according to the listing in par. 2b below.

c. The BC cards (Press Cards) are 5 x 8 mimeographed cards which contain extracted items of intelligence value, based on Russian newspapers and periodicals.

2. Distribution Instructions.

a. 1) All overall studies, complete translations or extract translations, with the exception of the detailed RR Line studies are disseminated in the following fashion.
