MEMORANDUM FOR THE RECORD

SUBJECT: Concurrence in Contract No. NY-4-2130 with The Perkin-Elmer Corp., Norwalk, Conn. [redacted] Project AQUATONE (Navy).

1. This memorandum contains a recommendation submitted for approval of the Project Director. Such recommendation is set forth in Paragraph 7.

2. This contract covers the procurement of 5 sets of 24" f/8 lenses. These lenses will be shipped to Hycon Mfg. Co. as GFE for inclusion by them in the Model HR-818 camera. The cameras are being produced by Hycon Mfg. Company for delivery to Navy under Contract No. NE-TB-711 [redacted] (NY-1).

3. This contract is fixed price in the amount of \$13,025.00 which should be charged during Fiscal Year 1958 to "No Year" Navy funds.

4. Three sets of raw glass were surplus to the Project and has been furnished as GFE to P & E to be used in manufacturing the lenses called for by this contract. It has been decided not to replace the raw glass in Project stock therefore \$1983.00 of the Navy funds should be charged to cover the project glass furnished P & E.

5. By concurrence to this memorandum the Project Comptroller signifies that sufficient funds are available for obligation of the amounts stipulated in paragraphs 3 and 4 above.

6. Certification of funds for this contract will be handled under the procedure approved by the Director of Central Intelligence on 15 December 1956, which in effect results in all 10(b) expenses involving issuance of Treasury Checks being accumulated in a separate account within the Finance Division. The amounts in this account will be periodically scheduled for certification of the vouchers by the Director. This procedure eliminates the necessity for a separate certification of authority under Section 10(b) of Public Law 110, 81st Congress, for each contract.

I hereby authorize withdrawal of this amount, \$1983.00 from that advance working funds from Navy.
