**SUBJECT: Shipping and Marking Instructions for
"Project Dragon Lady"**

TO: All Suppliers

1. Effective 3 June 1957, the Weapon System Support Center for F.O.G., presently located [redacted] will move to Warner Robins Air Materiel Area, Robins Air Force Base, Georgia. This move is expected to take three weeks and will be accomplished by airlift from [redacted] to WRAMA and Laughlin AFB, Texas.

2. Effective 27 May 1957, all shipments from the various suppliers to [redacted] in support of the F.O.G. program will be discontinued. Subsequent to 27 May 1957, suppliers will take the following action relative to packing, shipping, and marking instructions for material shipped from suppliers to the Weapon System Support Center, WRAMA:

a. All supplies and equipments will continue to be packed in a secure manner identical to the packing procedures now in use.

b. The nomenclature or noun which identifies the contents will not be indicated on the container; the manufacturer's part number will be the only identification marking on the container. Mark outside of containers:

c. Four (4) copies of the sterile shipping document or packing list will be enclosed and should itemize material shipped, indicating part numbers and quantities. Nomenclature of the contents shall not be listed unless, and ONLY when, a part number is not available. In preparing the shipping document, the following format should be used:

3. On 3 June 1957, the F.O.G. Weapon System Support Center will begin operating at WRAMA in a secure warehouse under the same security procedures which have been effective at [redacted] will continue to supervise the WRAMA warehouse function, and contacts with him will continue to be made through personal recognition or by sterile telephone. You will be provided with the telephone listing by [redacted] No calls to the WRAMA warehouse will be routed through the WRAMA base telephone system. [redacted] will also provide each supplier with the names of key persons at WRAMA who will be authorized to contact the various suppliers.

4. Suppliers will take such action as necessary to insure that no material destined for the F.O.G. depot at WRAMA arrives there before 4 June 1957. Circumstances arising, which are not appropriately covered by this directive, may be resolved by personal or telephone contact with [redacted] at WRAMA or with the F.O.G. WSPO at Wright-Patterson Air Force Base. Special instructions relating to certain equipment from West Coast suppliers who previously have made direct deliveries will be forthcoming and procedures developed as applicable in the individual case.
