Gentlemen:

1. This document constitutes Amendment No. 1 to Contract No. SC-45-12 between The Perkin-Elmer Corporation and the United States Government.

2. Pursuant to the clause of this contract entitled "Changes" and mutual agreement between the parties hereto, it is necessary and in the interest of the Government to amend the contract in certain particulars as follows:

a. Paragraph E. under Item 1 in APPENDIX I to the contract schedule is deleted and the following paragraph is substituted therefor:

E. Furnish all parts, except castings, in the overhaul of the Tracking Cameras.

b. By reason of the foregoing the unit price and total price of Item No. 1 is changed to read:

d. PART II - CONSIDERATION AND PAYMENT in the contract schedule is deleted and the following is substituted therefor:

PART II - CONSIDERATION AND PAYMENT

In accordance with the clause of this contract entitled "PAYMENTS," and subject to redetermination of the price in accordance with the part of this Schedule entitled "PRICE REDETERMINATION," the Government shall pay the Contractor upon satisfactory performance of this contract, as full payment for the services and equipment to be furnished by the Contractor hereunder the amount of NINETY-SEVEN THOUSAND EIGHTY DOLLARS (\$97,080), which amount is the total target price of Items Nos. 1, 2, 3, 4 and 5 in APPENDIX I, hereto.

e. In PART IV - PRICE REDETERMINATION of the contract schedule the last sentence of Paragraph C. is deleted and the following sentence is substituted therefor:

In no event shall the redetermined price exceed the sum of ONE HUNDRED FIVE THOUSAND NINE HUNDRED DOLLARS (\$105,900).

3. All other terms and conditions of Contract No. SC-45-12 shall remain the same.

4. Please indicate your acceptance of this Amendment No. 1 to Contract No. SC-45-12 by signing the original and two copies of this document. The original and one copy are to be returned to the undersigned and the remaining copy is for your files.
