25X1 1. [redacted] LIAISON Received a call from Mark Gitenstein, Senate Judiciary Committee staff, formerly of the Senate Select Committee on Intelligence staff. Gitenstein said a friend of his, [redacted], had recently been rejected for employment with the Agency. Gitenstein said [redacted] was very interested in employment here and would like to know if anything such as further education or language training would improve his chances. I told Gitenstein I did not know what I could say on the case but I would look into it.

I asked Gitenstein if he would meet with [redacted], OLC, to discuss the amendment before the Senate Judiciary Committee to the Federal Tort Claims Act. After some inconclusive discussion, I told Gitenstein I thought I should have [redacted] call him directly.

[redacted] LIAISON Accompanied Senate Select Committee on Intelligence staff members Mike Gelacek and Tom Crowley and House Permanent Select Committee on Intelligence staff members Fred Hull, Ira Goldman and Arlene Marek to a series of orientation briefings on CIA. Participants were [redacted] O/Compt, who gave an overview of the Agency, Zeke Zellmer, A/DDS&T, [redacted] C/PCS/LOC, [redacted] CSS/NFAC, and [redacted] EO/DDA.

25X1 3. [redacted] LIAISON Received a call from Tom Moore, Senate Select Committee on Intelligence staff, and discussed the status of his request on [redacted]

25X1 4. [redacted] LIAISON Took a call from Elaine George, in the office of Senator Paul Sarbanes (D., Md.). George said that Clifford Hackett, on the Senator's staff, had just received a copy of an unclassified Agency publication entitled "Economic Indicators Weekly Review" and wanted to be put on regular distribution for the publication. I explained the Director's new policy of providing unclassified studies to Senators routinely and that the Senator's office would regularly get all these publications through the Senate Select Committee on Intelligence. George said she would pass this along.

[Redacted] LIAISON Called Tom Smeeton, Minority Staff Consultant, House International Relations Committee, to discuss several matters related to the briefing on the North Korean subversive activities scheduled to be given to the Subcommittee on International Organizations on 3 August. Smeeton suggested that it would be appropriate for Chairman Donald M. Fraser (D., Minn.) to make some remarks regarding the proper treatment of classified information.

[Redacted] LIAISON Called Mike Hershman, Deputy Staff Director, House International Relations Subcommittee on International Organizations, to ask whether he could arrange for Subcommittee Chairman Donald M. Fraser (D., Minn.) to read a brief statement that we would prepare on the handling of classified information and the need to treat the identity of the Agency's briefer with the utmost discretion when we brief the Subcommittee on North Korean subversive activities on 3 August. Hershman said this would be no problem, and I said I would get the statement to him early next week.

[Redacted] THIRD AGENCY Took a call from [Redacted] Office of Legislative Affairs, NSA, who said that NSA had informed Mike Epstein, on the staff of the Senate Select Committee on Intelligence, that he was not authorized to show NSA documents in his possession to staff members of the Senate Select Committee on Ethics. I told [Redacted] that we had earlier in the day informed Epstein that three Senate Ethics staffers had received SI briefings, and thus could be exposed to this compartmented information, but that we had specifically cautioned Epstein that this notification was not meant to imply in any way that we were authorizing him to show documents which were the property of another Agency to the Senate Ethics staffers.
