6. The Chairman briefly reviewed a 25 October letter that the Director of Intelligence and Research, Department of State, wrote to the Director of Central Intelligence. This contained a proposal for a coordinated study on the economic vulnerability of East Germany. An ad hoc working group of the EIC was set up in response to this suggestion. [REDACTED] ORR, was appointed Chairman and others in the group were from CIA/ORR and the Department of State.

7. Action: The EIC reviewed EIC-R-18 and, after minor revisions were made, approved it. It was agreed that the editors and EIC/S should make whatever further editorial changes were considered necessary. The anticipated distribution date for the report is 30 December.
