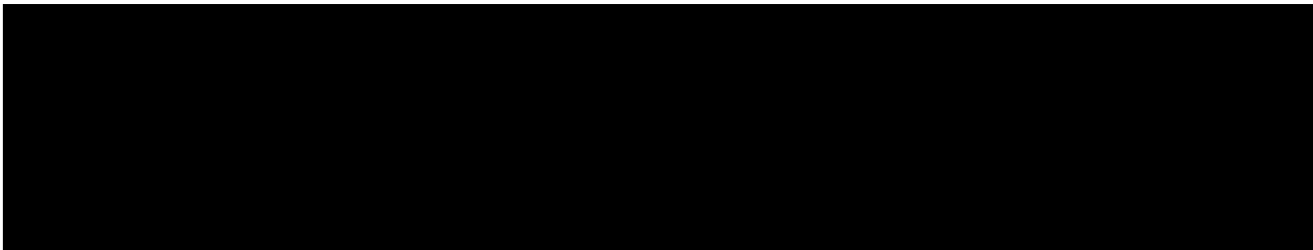

ORIGIN

- Sauerbrey Maschinenfabrik A.G., Stassfurt
Mining equipment manufacturers, employing 400 men under Soviet control. At present working on a contract to provide the complete equipment for a lime-shaft in the USSR.
- Sodafabrik Stassfurt
All modern equipment dismantled but, because of an uneconomical method of work, the number of employees has risen to 600. Head of the Works Council is M6bius. Factory is independent of Soviet control.
- Akt. Zuckerfabrik Marienstuhl, Exeln
Modern equipment completely dismantled.
- Zuckerfabrik Wiersdorff, Becker & Co., Gr6ningen
Refinery completely dismantled.
- Werk Leopoldshall (sic)
Underground storage space comprising twelve tanks, each holding 120,000 liters; at present eight are full. Unloading and loading into tank-cars is done hydraulically and very quickly, involving little human labor, so that it is not easy to check the tank-car traffic. Glycerine, castor oil, and motor oils are also stored here. The storage is under Soviet control. Head of the Works Council is Koch (SPD).
- Preussische Bergwerks and H6tten A.G., Stassfurt
Soviet-controlled salt and lime mining firm, employing 1,500 people. The director is von Klingsporn (SPD).
- Salinen & Salzbergwerke, Stassfurt
Soviet-controlled, employing 200 men. Head of the Works Council is M6der.(SPD).
- Ergelhan, L6derburg (sic)
Poison gas production; completely dismantled. Future of buildings as yet uncertain; 100,000 liters of poison gas still stored there. No one knows how to dispose of it.
