ORIGIN 25X1X6

1. The S.S.Smolny on Trip No.10, captained by G.Bondarenko, reached Shanghai from Vladivostok on 1 December 1946 and tied up at No. 1-2 lower Customs Buoys. Its cargo was under the supervision of handling agents G.E.Harden & Co. Ltd.
