at a Communist meeting in Chia-mu-ssu, the following men were listed in the positions described:
PENG Shih-lu 彭 施 魯, a commander in the Kirin-Liaoning Military District. (PENG Shou-lu 彭 守 魯, previously reported as Commanding Officer of the 7 Military Area at Chia-mu-ssu ?)
PENG Chen 彭 真, a commander in the Kirin-Liaoning Military District. (Shanghai Note: PENG has always been listed as a political rather than a military leader. He was identified as Chairman of the Political Committee for Manchuria.)
FANG Chiang 方 强, Commander of the Hochiang area. (See SO-1656 for previous identification of FANG.)
KANG Shu-cheng 楊 樹 成, Director of the Peace Preservation Forces. (Shanghai Note: Since no previous information regarding YANG has been received by this office, it is assumed that he is the director only of the forces in the Chia-mu-ssu area, not of all Manchuria.)
LI Yen-lu 李 延 錄, Mayor of Chia-mu-ssu. (Shanghai Note: Previously identified as Governor of Hochiang Province.)
