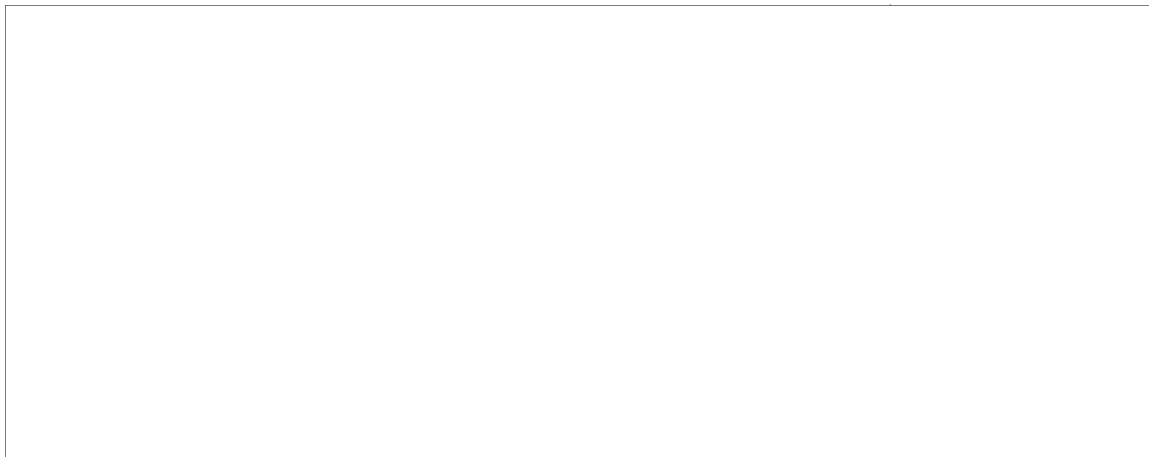

1. Dissatisfaction with expropriation procedures in Land Saxony-Anhalt led to well-substantiated protests to the Law and Constitutional Committee of the Landtag. The Committee undertook the investigation of expropriations based on Orders No. 124 and 126 and of errors of procedure in handling expropriated property. Expropriations were conducted very informally, since no regular procedure was legally established, no proper records were kept, no reasons were given for expropriations, and protests were not properly registered.
