Instructions to Communal Agents
(To be destroyed after reading)

1. The Chief of the reseau will designate in each commune in his sector : communal agent.
2. This communal agent is to report weekly to the Chief of the reseau on the activities of "separatists" and anti-national movements in his commune, even if these activities seem insignificant.
3. The communal agent is charged with recruiting sub-agents and informers. His mission is to secure the most complete information possible on "adverse" activities.
4. The communal agent is also charged with organizing his own security. He must keep strictly secret the names and addresses of liaison agents in his sector as well as the name of the Chief of the reseau.
5. On receipt of this order, he will secure information as quickly as possible on the following subjects:
 - a. Names, date and place of birth, profession, address and all pertinent information concerning the Communist Municipal Councilors and Communist candidates in the Municipal elections.

- b. Names of adherents to the Communist Party; name and designation of cells existing in the commune.
- c. Communist organizations existing in the commune with maximum details concerning their directors. (Union de la Jeunesse Républicaine de France, Union des Femmes de France, France-URSS, Front National, Francs-Tireurs et Partisans Français, Combattants de la Liberté, Association Républicaine des Anciens Combattants, Confédération Générale du Travail, etc.)
- d. The names of members of each of the above organizations.
- e. The names, etc. of the leading Communists who are considered as particularly active or dangerous.
- f. Listing of manifestations, meetings or reunions of the Communist Party or Communist organizations taking place in the commune with maximum details: place, hour, date, purpose, speakers, number of persons present, etc.)
- g. The communal agent will transmit weekly to the chief of the sector all tracts, local Communist papers and Communist hand-bills which he can obtain.

Capital importance is attached to the complete execution of these instructions.
