1. The local traditional heads of Southern Celebes have been appointed to their offices by Anak Agung Gde Agung, Prime Minister of East Indonesia, with the approval of the Dutch Resident Commissioner at Makassar. None of those appointed are Communists; they are all pro-Dutch.
2. Those who have been appointed are:
  - a. Department of Bone: Andi Pabenteng Daeng Blawa; Arumpono (for Bone proper); Andi Mangkong; Aru Matowa (for Fajo); Andi Singke; Arung Udjung for Seppeng).
  - b. Department of Luwu: Andi Ibrahim; Opu Patuuru (for Luwu proper); Andi Lolo; Puang Makale (for Toradja).
  - c. Department of Parepare: Andi Tjale; Sulewatin Sawitto (for Pinrang).
  - d. Department of Mandar: Kambo; Pabitjara Rangga (for Madjaene); La Magga; Alu Malolo (for Binuang).
  - e. Department of Buton (island) and Laiwui: Lsie Fihili; the Sultan of Buton; Rongga; Sepati Laiwui.
  - f. Department of Makassar: Andi Tjalla Daeng untu; Kraeng Labakkang (for Pangkadjene), Andi Idjo Kareng; Laholan, Somba Goa.
  - g. Department of Bonthain: Abdul Ganj (a native of Java who has lived for many years in Bonthain); Kraeng Gantarang (for Bulukuma); Andi Mapatoba; Arung Bulu-hulu Timur (for Sindjai).
